IN ACCORDANCE WITH THE DECISION ISSUED BY THE NATIONAL TASKFORCE FOR COMBATING THE CORONAVIRUS' (COVID-19), THE FOLLOWING PROTOCOLS SHALL APPLY EFFECTIVE 24 MAY 2021 20:59

1.VISA ON ARRIVAL IS AVAILABLE TO ALL ELIGIBLE PASSENGERS DISEMBARKING BAHRAIN.

2.PASSENGERS ARE NOT ALLOWED TO ENTER BAHRAIN, UNLESS THEY ARE:

- BAHRAINI CITIZENS
- GCC CITIZENS WHO DO NOT REQUIRE VISAS
- PASSENGERS WHO RESIDE IN BAHRAIN
- PASSENGERS WITH A VALID Evisa GRANTED PRIOR TO BOARDING
- PASSENGERS WHO ARE ELIGIBLE FOR VISA ON ARRIVAL
- THIS DOES NOT APPLY TO AIRLINE CREW
- THIS DOES NOT APPLY TO MILITARY PERSONNEL

3.PASSENGERS FROM THE GULF COOPERATION COUNCIL (GCC) WHO ARE FULLY VACCINATED OR RECOVERED ARE NO LONGER REQUIRED TO UNDERGO A PCR TEST UPON ARRIVAL.

GCC PASSENGERS SHALL SHOW EVIDENCE OF VACCINATION OR RECOVERY THROUGH A CERTIFICATION OR AN OFFICIAL GCC MOBILE APPLICATION. THIS DECISION, AS WELL AS THE DECISIONS BELOW, DO NOT EXTEND TO PASSENGERS BETWEEN THE AGE OF 6 AND 17.

4.PASSENGERS FROM COUNTRIES (HUNGARY, CYPRUS, GREECE AND ISRAEL) WITH MUTUAL RECOGNITION OF VACCINATION CERTIFICATES WILL ALSO NOT UNDERGO PCR TESTS UPON ARRIVAL, IF EVIDENCE OF A RECOGNIZED VACCINE IS PROVIDED.

5.ALL PASSENGERS ARRIVING FROM RED LIST COUNTRIES, NAMELY INDIA, PAKISTAN, BANGLADESH, SRI LANKA, NEPAL AND VIETNAM, INCLUDING PASSENGERS WHO HAVE TRANSITED THOSE COUNTRIES AT ANY POINT WITHIN 14 DAYS OF THEIR INTENDED ARRIVAL IN BAHRAIN, ARE PROHIBITED FROM ENTERING BAHRAIN

BAHRAINI NATIONALS AND PASSENGERS HOLDING A VALID RESIDENCY VISA ARE EXEMPTED FROM THE ABOVE RESTRICTION, PROVIDED THEY PRESENT A NEGATIVE TEST CERTIFICATE WITH A QR CODE FOR A PCR TEST ADMINISTERED WITHIN 48 HOURS OF THEIR DEPARTURE. PASSENGERS ARE ALSO REQUIRED TO UNDERGO A PCR TEST ON ARRIVAL AND ON THE 10TH DAY OF THEIR STAY IN BAHRAIN. PASSENGERS AGED 6 YEARS AND BELOW ARE EXEMPT FROM MANDATORY TESTING REQUIREMENTS. UPON ARRIVAL, PASSENGERS ARE REQUIRED TO QUARANTINE FOR 10 DAYS AT A GOVERNMENT DESIGNATED HOTEL LICENSED BY THE NATIONAL HEALTH REGULATORY AUTHORITY (NHRA) OR AT THEIR RESIDENCE. PASSENGERS MUST PRESENT PROOF OF A PREPAID RESERVATION IN THEIR NAME FOR A DESIGNATED QUARANTINE FACILITY BEFORE BOARDING A FLIGHT TO BAHRAIN. PASSENGERS THAT ELECT TO QUARANTINE IN THEIR OWN RESIDENCE MUST PROVIDE PROOF OF A RESIDENCE, EITHER OWNED OR LEASED BY THE PASSENGER OR AN IMMEDIATE FAMILY MEMBER BEFORE BOARDING.

PASSENGERS WHO HAVE NOT BEEN TO RED LIST COUNTRIES WITHIN 14 DAYS OF THEIR INTENDED ARRIVAL IN BAHRAIN

NON-VACCINATED PASSENGERS MUST PRESENT A NEGATIVE TEST CERTIFICATE WITH A QR CODE FOR A PCR TEST ADMINISTERED WITHIN 48 HOURS OF THEIR DEPARTURE. PASSENGERS ARE ALSO REQUIRED TO UNDERGO A PCR TEST ON ARRIVAL AND ON THE 10TH DAY OF THEIR STAY IN BAHRAIN. PASSENGERS AGED 6 YEARS AND BELOW ARE EXEMPT FROM MANDATORY TESTING REQUIREMENTS. UPON ARRIVAL, PASSENGERS ARE REQUIRED TO QUARANTINE FOR 10 DAYS AT A GOVERNMENT DESIGNATED HOTEL LICENSED BY THE NATIONAL HEALTH REGULATORY AUTHORITY (NHRA) OR AT THEIR RESIDENCE.

PASSENGERS MUST PRESENT PROOF OF A PREPAID RESERVATION IN THEIR NAME FOR A DESIGNATED QUARANTINE FACILITY BEFORE BOARDING A FLIGHT TO BAHRAIN. PASSENGERS THAT QUARANTINE ELECT TO QUARANTINE IN THEIR OWN RESIDENCE MUST PROVIDE PROOF OF A RESIDENCE, EITHER OWNED OR LEASED BY THE PASSENGER OR AN IMMEDIATE FAMILY MEMBER BEFORE BOARDING.

PASSENGERS WITH VALID VACCINATION CERTIFICATES, RECOGNIZED BY THE GOVERNMENT OF BAHRAIN, ARE EXEMPT FROM THE TESTING AND QUARANTINE REQUIREMENTS

PASSENGERS WITH VALID VACCINATION CERTIFICATES ISSUED BY PUBLIC HEALTH AUTHORITIES IN THE USA, CANADA, THE UK, AUSTRALIA, NEW ZEALAND, JAPAN, S KOREA AND SINGAPORE OR THE EU ARE EXEMPT FROM MANDATORY QUARANTINE REQUIREMENTS BUT MUST UNDERGO A PCR TEST UPON ARRIVAL AND AN ADDITIONAL TEST ON THE 10TH DAY OF THEIR STAY IN BAHRAIN.
